

**Waiver of Liability and Assumption of All Risks
For Participants Under the Age of 18 * Please Read Carefully ***

Summary: Prior to using Ray's indoor mountain bike park in Milwaukee, Wisconsin, your parent/guardian must consent, in writing, to your use of this facility in accordance with the following terms. Prior to admission, you and your parent/guardian are free to elect one of the following options: (1) sign this Waiver and pay the standard admission fee or (2) do not sign this Waiver and pay the premium admission fee. By signing this Waiver, your parent/guardian is agreeing that both you and your parent/guardian will not sue Ray's Indoor Mountain Bike Park, LLC ("Ray's") or any other person for any claims that may arise from your use of this facility. You and your parent/guardian assume total responsibility for injuries or damage you may sustain arising from admission to this facility, as further detailed below.

1. You Are Solely Responsible for Your Safety. Bike riding, including doing jumps and stunts on your bike, and riding on skinnies, teeter totters and various other structures and apparatus at our indoor mountain bike park, is an inherently dangerous activity that can result in injuries, damage to property, and other losses. By signing this Waiver, your parent/guardian acknowledges these dangers on your behalf and confirms that you assume all the risks associated with your use of this facility, including risks arising from your conduct (whether as a participant or spectator), the design of the course, the conduct of Ray's and its employees, the conduct of other participants, and the conduct of persons who own or control the premises.

2. You Agree to Not Hold Ray's Responsible. In exchange for the privilege of engaging in the inherently dangerous activity of bicycling at this facility or observing such activity, you and your parent/guardian agree to release Ray's, any person whom Ray's has agreed to indemnify, and their employees, agents, and affiliated companies from any liability that may arise from your presence at this facility. This release applies, for example, to injuries or damages related to your conduct, bicycle and equipment, the conduct or equipment of other participants, the design of the course, the condition of the course and facility, and the conduct of Ray's and its employees, even if such conduct by Ray's or its employees is negligent.

3. Related Promises by Parent/Guardian. The parent/guardian signing this document represents that he or she has the legal authority to (1) sign this Waiver on behalf of the participant and (2) waive the participant's legal rights in accordance with the terms of this document. The parent/guardian also represents that he or she has read this Waiver and understands its contents. The parent/guardian further agrees that this Waiver will continue in full force and effect and shall apply to all of the participant's future visits. The parent/guardian further acknowledges that his or her signature below is made voluntarily, after having the opportunity to inspect the course and consider alternatives, which include not allowing the participant to use this facility or allowing the participant to use this facility without signing the Waiver and for the premium admission fee. You agree that any lawsuits related to this Waiver or the facility shall be filed, and exclusively litigated, in the Circuit Court for Milwaukee County, Wisconsin.
